Both parties have agreed to the following terms of sale:

The Seller Agrees:

_____ This puppy/dog is in good health at the time of sale.

The buyer will have seven (7) days to have the puppy examined by their own veterinarian. During that time, the puppy may be returned due to illness from any health condition deemed present prior to removal of the puppy from Seller's premises. WestWood requires a letter from the veterinarian that clearly states the health problem. Buyer shall assume any expenses associated with returning this

puppy to the Seller. Puppies may be returned for other reasons at any time during the life of the dog with the permission of the seller however no refund will be given.

_____ This puppy is not guaranteed to become a Champion or earn titles.

At the time of sale, said puppy shows no defects which would disqualify it from the show ring according to the breed standard.

_____ Every reasonable precaution has been taken to prevent this puppy from acquiring hereditary hip dysplasia, cataracts, or Subaortic Stenosis.

Due to the unknown hereditary and environmental causes of such defects, no guarantee can be given against them. However, should this puppy develop any of the aforementioned problems and they are deemed hereditary by 26 months of age, WestWood Goldens will refund one-half of the purchase price within six months of notification.

Notification shall include:

- ✓ Written verification from OFA (hips)
- ✓ CERF (eyes)
- ✓ Board Certified Cardiologist (heart)

*The Buyer shall also provide written verification from a veterinarian that the dog has been spayed or neutered. No refund will be given if the dog is not examined by 26 months of age or if the dog has been previously bred. **This refund policy applies only to the original buyer.***

_____ If this puppy/dog is being sold on a pet contract, the Buyer agrees to have the puppy/dog spayed or neutered by the time the animal reaches one year of age. The Buyer will provide the Seller with written verification from a veterinarian.

The Buyer Agrees:

_____ This puppy/dog will be given adequate and proper shelter and housed securely.

*This dog shall **not be neglected, allowed to roam free, or mistreated in any manner.** This puppy will not routinely be tied or chained to a stationary object such as a tree or post.*

_____ This puppy/dog shall receive proper veterinary care throughout its lifetime, receiving annual inoculations and placed on preventative heartworm.

_____ This puppy/dog will receive proper nutrition and care taken to maintain its proper weight.

_____ The Buyer shall notify the Seller first if *for any reason* the Buyer no longer wants or is able to keep the puppy. The Seller shall have first right of refusal if the pup is to be sold or disposed of in any way. If the Seller does not wish to have the puppy/dog
